A note about the donation in lieu of the Swim Challenge: The Board feels that hosting the State Meet this year gives us, the swimmer families, plenty to do and that organizing a Swim Challenge to raise funds would place too much of a time burden on our swimmer families. We decided to skip the Swim Challenge and instead ask our swimmer families for a donation to help our swim team meet its obligation to the City of Golden for pool rental fees. Our recommended voluntary donation is \$50 per swimmer family. The Golden Marlins is a 501(c)3 non-profit organization and all donations are tax deductible.

The Golden Marlins Swim Team runs on parent power. Your \$150/season per family deposit will be destroyed at the end of the summer swim season upon completion of all your volunteer sessions. This year we are asking each swimmer family to fill 4 volunteer sessions during the regular swim season plus 1 volunteer session for the State Meet. *Note that most of the State Meet volunteer sessions take place before the actual State Meet itself.* Session descriptions and sign-up sheets will be available at the Registration Meeting and at afternoon swim practices in May.
